Covenants and Guidelines Review: The committee of volunteers from the Annual Meeting will be organized and begin the process.

Crime Watch: A neighbor reached out to Rob regarding an incident of intimidation in the neighborhood to make others aware.



Foundation: The Foundation would like to propose installation of message boards in each of the large parks. A neighbor has offered to build a sign similar to the one at the Herron-Morton Alabama St. Park. There will be no cost to the homeowners association. The board unanimously authorized the construction and installation of the boards in the 25th St. and Craig Kids parks.

Pancakes and Pints fundraiser by the foundation in conjunction with Mash Craft will be held Saturday, February 10, 2024.

Chris has applied for a foundation grant through the Indianapolis Neighborhood Resource Center to continue the efforts to remove invasive trees along the Fall Creek trail and to further stabilize and replant native trees.
